- No refit work to vessels permitted in marina, minor repair works only permitted. If clarification required, please contact wharf manager. Port Nikau's Eastpoint Marina or wharves are available for refit work.
- Foreign vessels requiring GST (Tax) exempt supply must provide a current copy of their TIE on arrival.

Marina Pricing Notes:

- Minimum charge of 3 days may apply.
- Unarranged berthage or incomplete documentation will incur a penalty of \$100 documentation fee and may result in the vessel being refused berthage.
- No charge for day of departure if gone by midday. Otherwise a full day's charge applies.
- All vessels must hold a current Electrical Warrant of Fitness and Tagged Lead to connect to our electrical supply.
- Sewage pump out facilities available for vessels berthed for longer than one month, contact Wharf Manager for use. Service fee will apply to vessels berthed for less than a month.
- Vessel movements are subject to security camera surveillance
- All vessels must provide a copy of a current Insurance Certificate with minimum \$5m marine hull liability insurance. Failure to provide a certificate will result in a penalty of \$100/day.
- A maximum of one 4-month period per year of berth reservation for return is available at 50% of the boats berthage rate at the discretion of the Wharf manager. Port Nikau have the right to sublease the berth while vacant.
- All vessels are subject to Port Nikau Terms and Conditions.

- Minimum charge \$200 including load/unload stopover on Mains Wharf and Arataki Wharf. Fee waved if berthage exceeds \$200.

Conditions for Fishing Boat Shared Berths:

- Available to fishing vessels only that wish to secure flexible berthage on a permanent basis
- Arataki wharf only
- Boats must be willing to raft-up with other fishing boats if required
- Occupancy no more than 60% per boat per annum

Wharves Pricing Notes:

- Minimum charge \$200 including load/unload stopover. Fee waived if berthage exceeds \$200.
- For boats over 40m with a stay of less than 5 days a fee of \$250 applies to cover arrival and departure.
- No charge for day of departure if gone by midday. Otherwise a full day's charge applies.
- All berthage (including for load/unload) must be arranged with the Marina Manager in advance
- Unarranged berthage or incomplete documentation will incur a penalty of \$100 documentation fee and may result in the vessel being refused berthage.
- Vessel movements are subject to security camera surveillance
- All vessels must provide a copy of a current Insurance Certificate with minimum \$5m marine hull liability insurance. Failure to provide a certificate will result in a penalty of \$100/day.
- All vessels must hold a current Electrical certification and provide to Port Nikau upon request and tagged and tested shore power lead if connecting to shore power supply.
- For vessels rafted alongside a rate half of that advertised applies.
- All vessels are subject to Port Nikau Terms and Conditions.

(1) Q-Shed is a 100m2 workshop with a high stud and full height access doors. The workshop is equipped with 2-ton gantry, power and water which are included in the weekly rental price. Note Agreement to Lease required with booking of space in advance.
